# RE: MANAGEMENT OF CAULERPA TAXIFOLIA OUTBREAK

### 1. PROPOSAL

1.1 That Her Excellency the Governor in Executive Council promulgate the Harbors & Navigation (Control of Caulerpa Taxifolia) Regulations 2002 under the Harbours & Navigation Act 1993 to extend the current quarantine of West Lakes for management of the Caulerpa taxifolia outbreak to 31 December 2002.

## 2. BACKGROUND

- Cabinet on 17 June 2002 approved the promulgation of regulations under the Harbors & Navigation (Control of Caulerpa Taxifolia)
  Regulations 2002 to quarantine the Lake by banning all aquatic activities.
- 2.2 Cabinet on 16 September 2002 approved the drafting of the Harbors & Navigation (Control of Caulerpa Taxifolia) Regulations 2002 to quarantine the Lake by banning all aquatic activities to 30 September 2002.

# 3. **DISCUSSION**

- 3.1 To allow sufficient time for treatment, it is proposed that the extension date *be* pushed out to 31 December 2002.
- 3.2 All of the existing exemptions for water users (rowing, dragon boats, Canoe SA) will be re-issued on amendment of the Regulations and others exemptions will be considered as compliance within the community has been excellent so far.
- 3.3 **P**arliamentary Counsel has drafted new regulations in line with the Cabinet Approval of 16 **S**eptember 2002 to extend the closure.


